# General terms and conditions

To benefit from the services offered by Les Méditerranées, please read the general terms and conditions below carefully. These conditions govern the sale of holiday stays and are valid from the moment the order is placed. Booking a stay at Les Méditerranées implies that you fully accept our general terms and conditions.

## BOOKING CONDITIONS

- The booking comes into effect solely with the agreement of Les Méditerranées, after receipt of the deposit and the completed and signed contract, or after acceptance of the general terms and conditions in the case of online bookings.
- All bookings are subject to acceptance by Les Méditerranées. Les Méditerranées is free to accept or to refuse any bookings, depending on availability and, more generally, any circumstances that may impede fulfilment of the booking. Les Méditerranées proposes family-oriented holidays, in the traditional sense; the accommodation is designed especially for this purpose. Les Méditerranées reserves the right to refuse any booking which does not comply with this principle, or which tries to abuse it.
- The booking of a camping pitch or rental accommodation is made on a strictly personal basis. Under no circumstances may you sub-let or transfer your booking without the prior consent of Les Méditerranées.
- Minors must be accompanied by their parents or legal guardians.
- The specific numbers of the camping pitches or the rentals are not guaranteed. In the event of force majeure or for scheduling requirements, the management reserves the right to change the camping pitch or rental cabin number.

**Camping pitches:** The basic price includes the pitch for the tent, caravan or camper-van for 1 or 2 people with one single car, as well as access to the toilet and shower blocks and campsite facilities.

**Rentals:** Rental accommodations are fully-equipped. The basic capacity is for 4 to 6 people, depending on the type of rental. Only one vehicle is accepted.

Les Méditerranées reserves the right to refuse access to the campsite village to groups or families who exceed the capacity of the rented accommodations. Additional installations or tents for children are not accepted next to the rentals.

**Booking fees:** Les Méditerranées does not charge booking fees for rental accommodation. For camping pitches, please see the contract.

## PRICES AND TOURIST TAX

- Prices may vary depending on the date of booking. To know more about the exact price in force, consult our website [www.lesmediterranees.com](http://www.lesmediterranees.com) or contact our campsites directly. The prices given are in euros per night, including VAT (see what our prices include on the previous page).
- Les Méditerranées may apply special offers during the season (periods and products to be determined).
- The tourist tax varies depending on the municipality.

## PAYMENT TERMS

- For reservations made more than 30 days before the first day of the stay, a deposit of 30% of the price of your stay must be paid at the time of booking. The remainder must be paid at the latest 30 days before the first day of the stay in the camping village.
- For reservations made less than 30 days before the first day of the stay, payment must be made in full at the time of booking.

## YOUR STAY

### 1. Arrival

- Depending on the period, the arrival dates are variable.
- Rental accommodation: on the day of your arrival at Les Méditerranées a deposit of €300 will be requested. The keys to your accommodation will be available as of 5pm.
- Camping pitch: on the day of your arrival, you may check in at reception from 2pm onwards.

### 2. During your stay

- Camper's should have personal insurance: campers are responsible for supervising their personal items (bikes, etc.). Les Méditerranées cannot be held responsible for any thefts, fires, bad weather, etc. or for any incidents involving the campers' civil liability.
- Every customer must comply to the campsite rules, as well as to the Les Méditerranées Charta.
  - Each registered tenant is responsible for any trouble or disturbances caused by the people staying with him/her (or visiting).

### 3. Departure

- **Camping pitch:** On the day of departure indicated on your contract, the pitch must be returned before 11:00 a.m. The site must be left clean.
- **Rental accommodation:** On the day of departure indicated on your contract, the rental must be returned, at a prior arranged appointment, before 11pm. The inventories are held from 9am to 11pm in low season and from 8am

to 11pm in high season. In the event of an early departure without an inventory or outside of these hours, the cleaning fee will be charged.

The accommodation must be returned in a perfectly clean condition and the inventory will be checked.

Any broken or damaged object will be at your charge, as well as the cleaning of the rental if necessary. The deposit will be returned at the end of the stay after deduction of a possible compensation for any noticed damage.

The retention of the deposit does not exclude compensation in case that the costs are higher than the amount of this one.

If the accommodation has not been cleaned properly before your departure, you will be charged a cleaning fee.

Cleaning package:

DECOUVERTE, COSY and COLLECTION rentals: €100. SIGNATURE Rentals: the cleaning package is included in the price.

- For any delayed departure, you may be charged one extra day at the current rate.

## PETS

Pets are accepted at Les Méditerranées, subject to a fee payable when you book, except dogs of category 1 and 2. When pets are authorised, they must be kept on a leash at all times. They are not allowed by the pools, in the food shops or buildings. The vaccination booklet for dogs and cats must be up to date.

## VISITORS AND SURCHARGES

Visitors must inform the campsite of their arrival and any surcharge must be paid at the reception. Visitors must pay a fee in order to have access to the pools and activities: €10/person. Their vehicle must be parked outside the campsite.

## IDENTIFICATION BRACELETS

When you arrive at the reception, you and every member of your party will receive a bracelet. You should wear it on your wrist during your stay; it will allow you to come and go freely on the three sites and to have access to the facilities.

## SWIMMING POOLS

Swimming shorts are strictly forbidden. Only swimming trunks or swimming suits (one piece or bikini for women) are allowed. The access to the swimming pool is regulated, some areas are reserved for adults. People under 18 benefit of certain access times.

## BARBECUES

It is strictly forbidden to light or use charcoal or wood burning barbecues. Only gas or electric barbecues are allowed.

## DISPUTES

In the event of disputes, the applicable jurisdiction will be that of the courts located in the municipality in which Les Méditerranées is situated. Any claims concerning non-compliance of services with contractual commitments must be made by registered letter with acknowledgement of receipt to Les Méditerranées.

The customer expressly accepts that Les Méditerranées cannot be held liable for any incorrect information communicated by its partners or by third parties, or for erroneous information contained in any paper or digital documents (brochure, website, social networks, etc.) concerning the campsites, and notably the photos, activities, services and operating dates. All the photos and texts used in the brochure, on the website and social networks or on partner websites are non-contractual and are solely used as an indication.

It is possible that certain activities or facilities proposed and mentioned in the description given in these communication materials may be cancelled, notably due to weather conditions or in cases of force majeure as defined by the French courts.

## PROTECTION OF INFORMATION

In accordance with the General Data Protection Regulation of 25 May 2018, we ensure the highest level of protection regarding your personal data. Your data are used to ensure the best possible service when processing

your booking and for sending personalised communication about Les Méditerranées.

You can consult our data protection charter on our website or may request a copy of it.

The information you provide when booking is confidential and will not be divulged to a third party. The information shall only be used to process your booking and to send you personalised communication about Les Méditerranées.

In accordance with the French Data Protection Act of 6 January 1978, you have the right to access, rectify and delete personal information concerning you. ## IMAGE RIGHTS

Les Méditerranées, and any person designated by Les Méditerranées to act on its behalf, reserves the right to use any photographs, videos, or sound recordings in which you might appear in its future publications. The sole purpose of this use is to promote the campsites and facilities and under no circumstances may the images be used to harm or damage your reputation. This authorisation is granted free of charge, and is valid for any country for a period of five years.

## KIDS' CLUB and TEEN CLUB

Children from 5 to 12 years old are welcome to attend the Kids' Club. Children under 5 years old will under no circumstances be accepted at the Kids Club.

The Teen Club is open for children between 13 and 17 years old in July and August only.

## SPONSORSHIP AND LOYALTY PROGRAMMES

## CANCELLATION AND CHANGES

### 1. Changing your booking

- Modifications to your booking can be made free of charge, subject to availability on the campsite.

- **In the event that we receive no written message** indicating your wish to postpone your arrival date, the accommodation may be made available for rent again 24 hours after the arrival date mentioned in the contract, and you will therefore lose your booking.

### 2. Services not used

Any stay that is unused, interrupted or cut short by you (late arrival, early departure) shall not be reimbursed.

### 3. Cancellation by Les Méditerranées

In the event of cancellation by Les Méditerranées, the amounts paid for the stay shall be fully reimbursed, except in cases of force majeure. A cancellation made by Les Méditerranées shall not give right to the payment of any compensation.

### 4. Cancellation by the camper

In the event that the stay is interrupted or cancelled by a customer who has not taken our cancellation insurance, Les Méditerranées shall not under any circumstances refund the amounts already paid and/or due. The 7-day right of withdrawal does not apply to outdoor hotels. Therefore no refund will be made (except for cancellation conditions)

## CANCELLATION INSURANCE

**Les Méditerranées offers cancellation and interruption insurance with the rental contract in partnership with Gritchen Affinity.** Cancellation insurance: for rentals €5/night – for camping pitches: fixed price of €18.

Should an event prevent a customer from fulfilling their booking, then the customer must notify the campsite of their cancellation by letter or email as soon as the incident occurs. If the incident is provided in the general terms and conditions (available on the website [www.campez-couvert.com](http://www.campez-couvert.com) or from the campsite itself), the customer must notify the insurance company within 48 hours and provide all the requisite information and supporting documents:
