PARTICULAR REQUESTS

General terms and conditions

To benefit from the services offered by Les Méditerranées, please read the general terms and conditions below carefully. These conditions govern the sale of holiday stays and are valid from the moment the reservation is made. Booking a stay or entering the establishment implies full acceptance of our general terms and conditions of sale and the regulations, which may be modified during the season in the event of force majeure.

BOOKING CONDITIONS

- The reservation becomes effective only with the agreement of Les Méditerranées and after the deposit has been received and after the reservation form has been duly completed and signed, or after the general terms and conditions of sale have been accepted when booking online.
- All reservations must be accepted by Les Méditerranées campsites. Les Méditerranées campsites are free to accept or refuse a reservation, depending on availability, and any circumstances that may affect the execution of the reservation made. Les Méditerranées campsites offer family oriented stays, in the traditional sense, the accommodation is specially designed for this purpose. Les Méditerranées campsites reserve the right to refuse any reservation which would be contrary to this principle, or which would seek to divert it.
- The reservation of a campsite pitch or rental accommodation is made on a strictly personal basis. Under no circumstances may you sublet or transfer your reservation without the prior consent of Les Méditerranées campsites.
- Minors must be accompanied by their parents or legal guardians.
- Pitch or accommodation numbers are not guaranteed. In case of planning necessity or in case of force majeure, the campsite reserves the right to change the accommodation or pitch number.
- The plans and photos of the accommodation are for illustrative purposes only. The layout and features of the rooms may vary from one model to another.

Camping pitch: The basic rate includes the pitch for 1 or 2 persons for a tent, caravan, or motorhome, one vehicle, and access to the sanitary facilities and reception infrastructures.

Accommodation: The rental is fully equipped. The capacity is from 4 to 8 places according to the type of accommodation. Only one light vehicle is accepted. Les Méditerranées campsites reserve the right to refuse access to the village to groups or families with a number of participants greater than the capacity of the rented accommodation. No additional installations or child tents are accepted next to the rented accommodation.

Booking fees: Les Méditerranées campsites do not charge booking fees for rentals. For camping pitches, booking fees are applicable according to the period.

RATES AND TOURIST TAX

- Prices may vary depending on the date of booking. To know the exact price, please check our website www.lesmediterranees.com or contact directly our campsites.
- Pitch:** This corresponds to one night for 1 or 2 people, excluding all surcharges and tourist tax. Prices are in euros and include VAT.
- Accommodation:** These prices are per night, excluding surcharges and tourist tax. All prices are in euros and include VAT.
- Les Méditerranées campsites may apply promotional offers during the season (periods and products to be determined).
- The amount of the tourist tax varies according to the city.

PAYMENT TERMS

- For reservations made more than 30 days before the beginning of the stay, a deposit of 30% of the amount of the services reserved must be paid at the time of booking at the camping-village. The balance must be paid at the latest 30 days before the beginning of the stay.
- For bookings made less than 30 days before the start of the stay, full payment must be made at the time of booking.

YOUR STAY

1. Arrival

- Depending on the period, the arrival days are variable.
- Rental accommodation: a deposit of €300 must be paid online before your arrival (€600 for Family PRESTIGE accommodation). You will be welcomed from 12:00 pm; the delivery of the keys is guaranteed by 5pm at the latest.
- Camping pitches: on the day of your arrival you will be welcomed from 2pm.

2. During your stay

- The guest is responsible for looking after his/her personal belongings (bicycle, etc.). Les Méditerranées campsites decline all responsibility in the event of theft, fire, bad weather, etc. and in the event of an incident that falls under the guest's civil liability.
- All guests must comply with the provisions of the rules and regulations as well as the Charter of the Mediterranean.
- Each guest is responsible for any disturbance or nuisance caused by persons staying with or visiting him/her.

3. Check-out

- **Camping pitch:** On the day of departure indicated on your form, the pitch must be vacated before 11am. If you depart after 11:00 AM, an extra day may

be charged at the current nightly rate. The pitch must be left clean.

- **Accommodation:** On the day of departure indicated on your form, the accommodation must be vacated, by appointment, before 10 am. In case of departure outside these hours, please come to the reception desk.

For any departure after 10 am, you may be charged for an additional day at the current nightly rate.

The accommodation will be left in a perfect state of cleanliness and the inventory can be checked. Any broken or damaged object will be at your expense, as well as the restoration of the premises if necessary. The deposit will be returned to you at the end of your stay after deduction of the indemnities retained, on a supporting invoice, for any damage noted by the inventory of fixtures at the end of your stay. The deposit will be returned to you at the end of your stay, after deduction of the compensation deducted, on the basis of a supporting invoice, for any damage found. The retention of the deposit does not exclude additional compensation if the costs are higher than the amount of the deposit.

The cleaning package (bookable 48 hours before your departure) is €70 in COSY and COLLECTION rentals. SIGNATURE and PRESTIGE rentals: the cleaning package is included in the price of the accommodation. If the accommodation has not been properly cleaned before your departure, a cleaning fee of €150 will be charged. The management reserves the right to apply penalties if it finds, out of a lack of respect, that the accommodation is returned in a flagrantly dirty or damaged state.

ANIMALS

Dogs are accepted at Les Méditerranées campsites, except those of category 1 and 2, subject to a fee payable at the time of booking. They must be kept on a leash at all times. Dogs are not allowed around swimming pools, in food shops, or inside buildings. The vaccination record as well as valid civil liability insurance may be requested. All other animals are strictly prohibited. In case of non-compliance with this rule, management reserves the right to apply financial penalties and/or terminate the stay without refund.

VISITORS AND EXTRAS

The number of visitors may not exceed the maximum occupancy of the pitch or rental accommodation. Subject to acceptance by the management, visitors may be admitted to the campsite under the responsibility of the campers receiving them. Visitors must first go to reception with their host and leave a proof of identity for the duration of the visit. Access to swimming pools and entertainment is subject to a fee for visitors: €10/person/day.

In this case, visitors must leave the campsite by 11 p.m. at the latest. Vehicles must be parked outside the campsite.

WRISTBAND

One wristband per person will be given to each guest at the reception desk upon arrival. It must be worn visibly on the guest's wrist during the stay and will give the guest free access to the 3 campsites.

SWIMMING POOLS

Wearing swim shorts or full-body swimwear is strictly prohibited. Only swimsuits are allowed (one-piece or bikini for women, swim briefs for men). Access to the swimming pools is regulated, with certain areas reserved for adults. Minors have access to specific time slots in the indoor pools.

BARBECUES

Charcoal and gas barbecues are strictly forbidden. Only electric barbecues are tolerated.

DISPUTE

In case of dispute, jurisdiction is delegated to the courts located in the place of presence of Les Méditerranées campsites.

Any eventual complaint concerning the non-conformity of the services in relation to the contractual commitments must be notified in writing (LRAR) to Les Méditerranées campsites.

CANCELLATION AND MODIFICATIONS

1. Modification of your reservation

Changes to your booking can be made, subject to availability in the camping complex. For each modification, a handling fee of €90 will be charged.

- Changes to your reservation can be made free of charge, subject to availability in the campings.
- Without a written message from you indicating a postponement of your arrival date, the accommodation may again be available for sale 24 hours after the arrival date mentioned on the contract, and you will consequently lose the benefit of your reservation.

2. Unused Services

Any stay and/or additional service not consumed, interrupted, or shortened (late arrival, early departure, etc.) on your part will not be eligible for a refund.

3. Cancellation due to Les Méditerranées campsites

In the case of a cancellation due to Les Méditerranées campsites, the sums paid will be refunded, except in case of force majeure.

4. Cancellation due to the guest

If the stay is interrupted or cancelled by a client who has not taken out insurance, Les Méditerranées campsites will not reimburse the sums paid and/or due under any circumstances. A handling fee of €90 will be charged.

The right of withdrawal of 14 days does not apply to the campsite. Consequently no refund will be made (except for cancellation conditions).

CANCELLATION INSURANCE

Les Méditerranées campsites offer rental contract cancellation insurance through their partner Gritchen Affinity: 4% of the total cost of the stay.

In the event of cancellation, the customer must immediately inform the campsite of their withdrawal as soon as an event preventing their departure occurs, either by mail or by email.
